- 3. Resolution #25-1 Bergenfield Revaluation Extension. The Bergen County Board of Taxation on August 18, 2022, issued an order to the Borough of Bergenfield to perform a district wide revaluation to be completed by October 1, 2023, for the 2024 Tax Year. The Division of Taxation approved said order on September 14, 2022. The Bergenfield Tax Assessor, by letter dated September 8, 2022, requested a one-year extension for the completion of the Revaluation program due to the updating of the Tax Maps and review by the Division of Taxation. And whereas, the Bergenfield Tax Assessor at the February 5, 2025 Board Meeting requested a further one-year extension for the completion of the Revaluation due to the updating of the Tax Maps and review by the Division of Taxation. Whereas since the Tax Map update has not been granted, a further one-year extension is necessary to complete the Revaluation program. The Bergen County Board of Taxation hereby approves the request by Bergenfield Tax Assessor for the Revaluation to be

completed by October 1, 2025, for the 2026 Tax Year. A copy of the Resolution will be filed with and approved by the Director of the Division of Taxation. A motion to approve was made by Commissioner Schuster and seconded by Commissioner Eilert, all were in favor.

- 4. Resolution #25-2 Assessor Correction Recommendations on the 2025 Tax Lists filed by Assessors for decreases were received for all 70 districts. The Board Members have reviewed the recommendations as set forth on said assessment corrections. As of March 5, 2025, the Bergen County Board of Taxation hereby approves said recommendations as set forth on each assessment correction for the 2025 Tax List. A motion to approve was made by Commissioner Schuster and seconded by Commissioner Eilert, all were in favor.
- 5. James Tighe Retirement Assistant Administrator McCarthy stated the Board has received a letter of resignation from Tax Assessor, James Tighe, from his municipalities: Teaneck, Garfield, and Rochelle Park; as of April 1st. President Calabrese asked how many years of service the Tax Assessor has provided to Bergen County, to which James Tighe stated 27 years. The Board thanked the Tax Assessor for his years of dedicated service to the municipalities and wished him the best in retirement. James Tighe thanked the Board and the County Board of Taxation for all their help over the years.
