Sarah Holbig, Appraisal Systems Inc., approached the Board to provide revisions and status reports regarding Closter, Cresskill, River Edge, Saddle Brook, and Westwood, which are now pending State approval, contract and AFR's were submitted. Additionally, Maywood and Moonachie are pending contract renewal. Administrator Layton stated once the letters from the State are received, the statuses will be updated.

Administrator Layton requested any Assessors whose towns are conducting Revaluations to still send in monthly status update letters. Administrator Layton stated the Board has received a total of 1,617 appeals which includes Assessor appeals; of that 1,334 are regular appeals.

Patrick Wilkins, Tax Assessor of Harrington Park, approached the Board. Harrington Park will be submitting a request to transition to a 2026 Reassessment Order from its current 2026 Revaluation Order. Administrator Layton stated for the request to be submitted in writing to the Board.

Patrick Wilkins, Tax Assessor of Rockleigh, stated there is an executed contract which was sent down to the State and is awaiting approval.

Tony Rinaldi, Tax Assessor of Mahwah, approached the Board. Mahwah Tax Assessor stated a letter will be submitted in request to transition to a 2026 Reassessment Order from its current 2026 Revaluation Order due to the Tax Maps.

Tony Rinaldi, Tax Assessor of Upper Saddle River, stated the township has been delayed in completing the Tax Maps due to an unprecedented increase in the invoice provided by the engineers. Upper Saddle River is in the process of either acquiring the incomplete Tax Maps or finding another firm to redo the Tax Maps. Administrator Layton requested the Tax Assessor to provide updates and if an extension is needed, to provide a letter stating the request and reasoning to the Board.
