# **Core Concepts**

#### **POWER AND CONTROL**

Domestic abuse is about more than isolated incidents—it's a r<u>elationship strategy</u> where fear, humiliation, verbal, and physical assaults are used to gain power and dominance. Abuse is a conscious choice made by the abuser, not an accident caused by external factors like substance abuse or mental health issues.

#### SURVIVOR-CENTERED APPROACH

Victim safety is our primary concern Committed to ensuring a victim's reality and experiences are always the basis of the group content

#### **ABUSIVE BEHAVIOR IS A CHOICE**

Abuse is <u>instrumental</u> in nature. It is a selective, intentional, and purposeful act aimed at controlling a partner.

#### ABUSE IS A LEARNED BEHAVIOR

Abuse is a learned behavior that can be unlearned and replaced with respectful, nonviolent, and non- controlling behaviors. Behavioral change does not occur until the consequences of the behavior outweighs its' benefits.

# THE SOLE RESPONSIBILITY OF THE ABUSER

Abuse is never a shared fault. The abuser alone is responsible, and interventions focus on ensuring personal accountability.

# The Abuse Intervention Program

AIP is a highly structured **32-week minimum intervention** built on offender accountability. It's not anger management or traditional therapy—it's a dedicated process focused on exposing and restructuring the thought patterns behind abuse and violence.

## **KEY PROGRAM FEATURES**

- Weekly 90-minute Group Sessions- individual therapy is contraindicated, and couples or family counseling may compromise victim safety.
- Addressing Distorted Beliefs- our psychoeducational curriculum and group format addresses core beliefs that fuel control and abuse, providing a powerful foundation for new, non-violent and respectful behaviors.
- **Expert-Led Facilitation** Sessions are led by experienced co-facilitators with extensive expertise in domestic violence.
- Inclusive Approach- facilitators represent diverse gender identities, fostering a well-rounded, supportive environment.

### ACHIEVING MAXIMUM EFFECTIVENESS IN AIP

- **Collaborative Risk Management:** Constant support via coordinated efforts among legal systems, community resources, healthcare providers, and survivor services.
- **Consistent Behavioral Messaging:** Clear expectations and consequences ensure accountability from the start.
- **Timely Engagement:** Early intervention—ideally right after the index assault.
- Survivor-Based Curriculum: Utilize empathetic understanding and partner perspectives when addressing cognitive distortions.
- Integrated Substance Abuse: Addressing substance abuse as part of a holistic recovery process.

# What is Coercive Control?

Coercive control is a relationship strategy using physical abuse, sexual abuse, isolation, manipulation, threats, intimidation, humiliation, harassment and social positionality in order to gain and maintain dominance, power and control over a partner.



# **Program Focus**

#### ACCOUNTABILITY

The program is designed to ensure that the responsibility for behavior change lies with the participant.

#### **EXAMINE BELIEF SYSTEMS AND BEHAVIORS**

Look critically at the ideas and actions that sustain violence and control.

#### EXPAND DEFINITIONS AND LANGUAGE

Broaden the participant's understanding of violence and controlling behaviors.

#### UNDERSTAND THE IMPACT

Discuss how the participant's violence affects current and former intimate partners, children, and even the perpetrator themselves.

#### **IDENTIFY AND PRACTICE ALTERNATIVES**

Learn non-controlling, respectful approaches that build a foundation of equity, respect, accountability, and equality.
