\*IMPORTANT: New County Treasury Payment Policy requires prize winners to complete a w9; 2 disclaimer forms; a "Vendor Info Form";

and apply for a NJ Business Registration Certificate, (BRC)

The sale of artwork is permitted but juried work MUST remain on display until 4:30 pm.

Spaces measure approximately 6' high x 8' wide each.  
Exhibitor spots reserved on a first-come, first-served basis.

The Division reserves the right to remove artwork  
it deems overtly violent or unsuitable for a viewing public of all ages,  
as well as any objects that obstruct the visibility of the exhibition or flow of pathways.
