WITH AUDIO VOTING FOR THE BLIND. VOTERS WHO HAVE DIFFICULTY VOTING DUE TO
BLINDNESS, DISABILITY, OR AN INABILITY TO READ OR WRITE MAY BRING A PERSON TO ASSIST
THEM AT THE POLLS OR MAY ASK FOR ASSISTANCE FROM THE POLL WORKERS. SAMPLE
BALLOTS ARE MAILED TO EVERY REGISTERED VOTER THE WEEK PRIOR TO THE ELECTION
LISTING THE OFFICES, CANDIDATES AND THE QUESTIONS TO BE VOTED.**
