In honor of the 250th anniversary of America's independence, this Directory cover commemorates Bergen County's important role in the founding of our nation and the Revolutionary War history that unfolded across its communities. The Revolution in New Jersey began on the cliffs along the Palisades, where General George Washington and the Continental Army launched their critical retreat across the Jerseys in 1776. During that campaign, both Continental and British forces moved through present-day Fort Lee, Englewood, Teaneck, New Milford, River Edge, Bergenfield, Leonia, Wallington, Lodi, Hasbrouck Heights, and Hackensack, forever linking Bergen County to the fight for American independence. Bergen County was also the site of the Battle of Fort Lee, the 1778 Baylor Massacre in River Vale, and the 1781 march of Continental and French troops toward Yorktown along what is now Route 202 in Oakland and Mahwah.

Established in 1683 as one of New Jersey's four original counties, Bergen County has remained connected to the American story for more than three centuries. This directory cover highlights Revolutionary War landmarks and historic sites throughout the County, while the back cover features a collection of historic postcards showcasing Bergen County's evolution through the past 250 years of American history. Today, Bergen County is New Jersey's most populous county and a diverse, dynamic center of economic activity, innovation, and culture. Its blend of historic legacy and continued progress continues to shape the region and strengthen New Jersey.

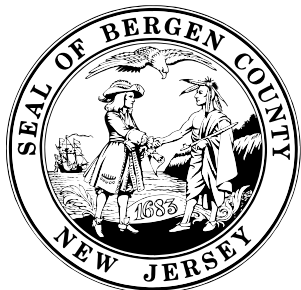

JAMES J. TEDESCO III

BERGEN COUNTY EXECUTIVE

James J. Tedesco III is serving his third term as Bergen County Executive—only the second person in county history to be elected to the office three times. Since taking office in 2015, he has centered his administration on **improving quality of life for residents, expanding essential services, and modernizing County government**. Under his leadership, Bergen County has made **record investments in public safety, infrastructure, parks and recreation, shared services, education, and community support programs**.

One of the earliest and most transformative initiatives Tedesco took was the **revitalization of Bergen New Bridge Medical Center**, the fourth-largest public hospital in the United States.



During his tenure, the medical center has undergone a comprehensive renaissance—expanding services, restoring morale, and establishing itself as a pillar of affordable healthcare in the region.

County Executive Tedesco has also **prioritized support for military veterans and their families**. Under his leadership, the County's Division of Veterans Services has expanded, and Bergen County became **one of the first communities in the nation to reach a functional zero for veteran homelessness**.

Investments such as the state-of-the-art Law and Public Safety Institute—**one of the most advanced emergency responder training facilities on the East Coast**—and **the creation of Bergen Emergency Medical Services** (Bergen EMS), a countywide, no-cost ambulance service, have strengthened emergency response capabilities and enhanced resident safety. Under Tedesco's Administration, these public safety efforts have rightfully earned Bergen County the distinction of the **Ninth Safest County in the Nation**, according to a U.S. News & World Report study.*

A core priority of County Executive Tedesco's administration has been ensuring that County government is responsive to the needs of its communities and reflective of the people it serves. **Bergen County is one of the most diverse counties in the nation**, and Tedesco's administration has worked to make that diversity a defining strength. This commitment to community is reflected by the fact that, under Tedesco's leadership, the County established two new permanent offices within the Department of Human Services: the Office of Food Security and the Office of LGBTQ+ Services. His administration has also taken meaningful steps to support working families and strengthen the County workforce, including making Bergen County the **first county in New Jersey to raise the minimum wage** for full-time county employees.

A volunteer firefighter for 50 years, Tedesco's **lifelong commitment to public service** has shaped his approach to leadership. He previously served as Fire Chief in his hometown of Paramus, as well as Mayor of Paramus from 2003 to 2010.

Tedesco is the father of three adult children—Koren, James J. Tedesco IV, and Holly—the proud grandfather of six grandchildren, and “dog dad” to Bergen, the first official “county dog” in New Jersey.

BOARD OF COMMISSIONERS

The Board of Commissioners is the County's legislative body, giving advice and consent to the actions of the County Executive. The board provides a check on the executive's powers and acts as a formulator of policy. Its powers include the ability to adopt the county's administrative code, pass ordinances and resolutions, review, modify, and adopt operating and capital budgets, and contract with municipalities.



STEVEN A. TANELLI
COMMISSIONER CHAIRMAN

During his time as a Commissioner, Chairman Tanelli has focused on fiscal oversight, shared services initiatives, and infrastructure improvements across the County. First elected in 2012, he has led key committees including Budget, Labor, and Parks, championed the County's first Parks Master Plan in 2019, and serves on the Open Space Trust Fund, Veterans, and Flood Advisory Councils. He holds a BA from Montclair State University, and currently resides in Paramus.



TRACY SILNA ZUR
*COMMISSIONER
VICE CHAIRWOMAN*

A lifelong Bergen County resident, Commissioner Vice Chairwoman Zur has helped advance County mental health initiatives, expanded access to health services, and supported public safety coordination efforts. She has implemented programs and initiatives such as Project SEARCH and spearheaded the formation of the Bergen County Food Security Task Force-now the Office of Food Security. She holds a BA from the University of Texas, an MPA from Rutgers University, and a law degree from Fordham University.

Dr. Joan M. Voss currently serves as Commissioner Chair Pro Tempore. A lifelong educator and former New Jersey Assemblywoman, she chairs the Planning and Engineering Committee. Her work centers on long term planning, education, and preservation, and she serves as liaison to cultural, historic, municipal, and education boards, including Bergen Community College and the County's vocational and special services districts.



MARY J. AMOROSO
COMMISSIONER

First elected to the Board in 2016, Commissioner Amoroso is an advocate for women, children, and families, and currently chairs the Community Development Committee. As Commissioner, she has focused on expanding human services, strengthening shared services, and supporting environmental and social service initiatives. Before her time as Commissioner, she was an award winning reporter for The Bergen Record. A Bergenfield native, she now lives in Mahwah and previously served on the Mahwah Town Council.



RAFAEL MARTE
COMMISSIONER

Appointed to the Board in 2023 after nearly 30 years as a social worker with the Westchester Department of Social Services, Commissioner Marte chairs the Information Technology and Public Works committees. As Commissioner, he has been a proud advocate of Social Services, Veterans, and Community Development. Commissioner Marte previously served two terms on the Bergenfield Council and founded the Dominican Cultural Association of NJ.



GERMAINE M. ORTIZ
COMMISSIONER

Germaine Ortiz was first elected to the Board in 2016, and became the first Latina to lead the Board as Chairwoman in 2019. She currently chairs the Public Works Committee as well as Human Services. As Commissioner, she has worked on public works improvements, County facility operations, and human service program expansion with an emphasis on equitable service delivery. She holds dual degrees in Spanish and Communications from Seton Hall University.



THOMAS J. SULLIVAN
COMMISSIONER

Commissioner Sullivan was first elected to the Board after decades of leadership in the building trades, beginning his career as an apprentice electrician and rising to President of IBEW Local 164 and later the Bergen County Building Trades. He chairs the Shared Services and Transportation committees and has championed resident advocacy throughout his tenure. He previously served on the Bergenfield and Montvale councils and lives in Montvale with his wife, Jody, and daughters Kenzie, Jadyn, and Kerrin.

CONSTITUTIONAL OFFICERS



PROSECUTOR Mark Musella

The **County Prosecutor** is the chief county law enforcement officer, tasked with investigating and prosecuting criminal offenders, fairly, impartially, and justly. The Prosecutor is appointed by the Governor to a five-year term.



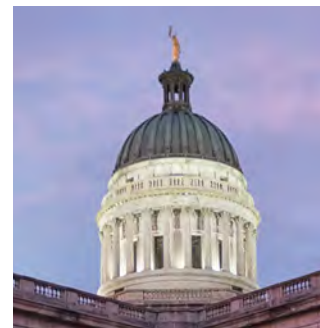
SHERIFF Anthony Cureton

The **County Sheriff** is responsible for the Bureau of Criminal Identification, Court Security, the Bergen County Sheriff's Detention Center, and the Detective Bureau. The Sheriff is elected to a three-year term.



COUNTY CLERK John S. Hogan

The **County Clerk** is responsible for recording and maintaining public records through the Registry and Counter Divisions as well as the operation of the Election Division. The Clerk is elected to a five-year term.



ACTING SURROGATE JUDGE Sharon A. Borys

The **County Surrogate Judge** admits wills to probate, appoints guardians, administers adoptions, and issues certificates of authority to executors of estates. The Surrogate Judge is elected to a five-year term.

EDUCATION IN BERGEN COUNTY

Bergen County public schools rank among the best in the nation. The County of Bergen supports two countywide school districts—the Bergen County Technical School District and the Bergen County Special Services School District.

Founded in 1942, the Bergen County Technical School District's secondary programs include Applied Technology High School, a full-time high school program with a concentration in engineering technology located on the campus of Bergen Community College; the Bergen County Academies, seven career technical high school programs that meld college prep classes with a career focus; Bergen County Technical High School/Paramus, a secondary program with a full-time option for special needs students and a shared-time option for students from local sending districts; and Bergen County Technical High School/Teterboro, a full-time program with nine technical concentrations. The district also offers full- and part-time technical instruction to over 18,000 secondary and adult students through the BCTS Adult and Continuing Education Division.

The Bergen County Special Services School District supports students with disabilities. Programs for students ranging from pre-elementary to secondary (ages 3-21) are structured around five separate divisions called continuums. These include the Auditory or Communication Skills Continuum, the Autistic Continuum, the Behavioral Skills Continuum, the Life Skills Continuum, and the Pre-School Continuum. Through these groupings, the district serves students with a variety of physical and cognitive disabilities. In addition, there are adult programs, professional support services for students, transition services, and other specialized programs that address the needs of the county and local school districts.

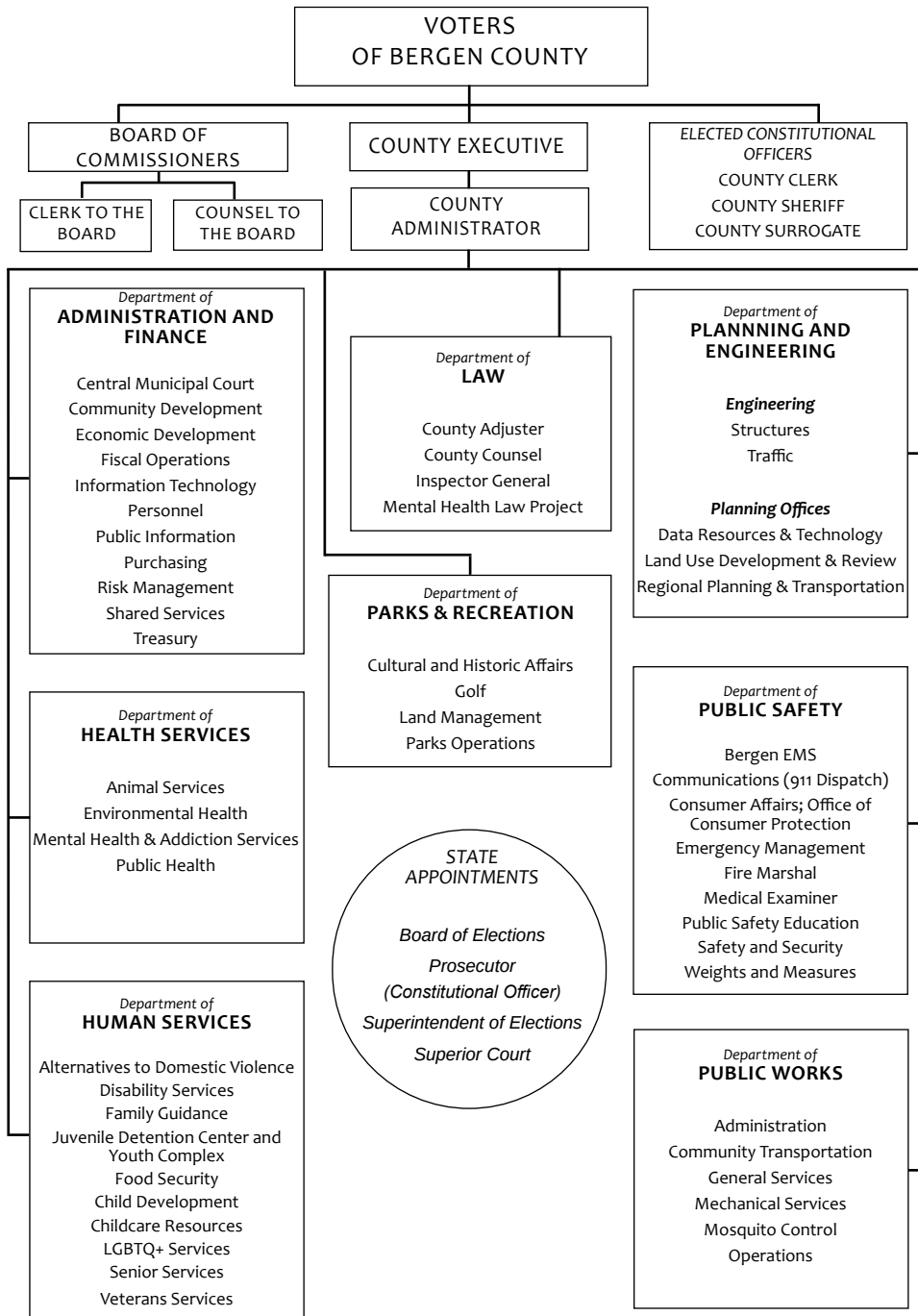

COUNTY DEPARTMENTS

The Department of Administration and Finance, led by the County Administrator, manages the day-to-day operations of County government and ensures, under the leadership of the CFO and County Treasurer, that the county has adequate funding to support these operations. The Department includes the Offices of Economic Development, Public Information, Information Technology, Fiscal Operations, Personnel, Community Development, Purchasing, Risk Management, Shared Services, and Treasury.

The Department of Health Services supports the health and well-being of the residents of Bergen County. Its divisions and programs include Addiction Recovery, Animal Control, the Animal Shelter & Adoption Center, Cancer Education & Early Detection, Environmental Health, Emergency Preparedness & Response, Health Promotion, Mental Health & Addiction Services, Office of Mosquito and Vector Control, and the Spring House for Women.

The Department of Human Services assesses the needs of the County's residents, manages resources to meet those needs, and coordinates delivery of resources to residents in need. The Department's divisions and programs include Alternatives to Domestic Violence, Office of Child Development, Division of Childcare Resources, Disability Services, Family Guidance, Office of Food Security, Office of LGBTQ+ Services, Senior Services, and Veterans Services.

The Department of Law, led by the County Counsel, maintains two divisions. The County Counsel's Office is legal counsel to the County Executive and the County's eight departments. Within the office of County Counsel, the Inspector General is tasked with promoting efficiency, accountability, and integrity in County government by investigating complaints of fraud and abuse. The Adjuster's Office is the liaison between the courts and the psychiatric institutions of the State. The Adjuster performs investigations and assists in the processing of firearm applications.

The Department of Parks oversees Bergen County's recreational and cultural facilities and is responsible for preserving open space, supporting environmental health, and protecting historic resources. The Bergen County Parks encompasses nearly 10,000 acres and includes a zoo, six golf courses, 21 parks, two horseback riding areas, an environmental center, and nine historic sites. The Department manages a broad range of programs and facilities that serve residents of all ages and abilities, supporting passive and active recreation throughout the County.

The Department of Planning and Engineering plans and manages projects and initiatives impacting land, the environment, transportation, and infrastructure throughout Bergen County. Its divisions include the Division of Engineering and the Division of Planning. Within those divisions include offices for Engineering-Structures, Engineering- Traffic, Office of Land Use, Development Review & Capital Projects, Office of Regional Planning & Transportation, and the Office of Data Resources & Technology. It also encompasses the Bergen County Planning Board and the Construction Board of Appeals.

The Department of Public Safety provides public safety services for the County. Included in this Department are the divisions of Safety and Security, Public Safety Communications, Consumer Affairs/Consumer Protection, Emergency Management, Medical Examiner, Bergen EMS, Public Safety Education, Weights and Measures, and the Law and Public Safety Institute.

The Department of Public Works maintains the county's 452 miles of roads, 173 bridges, and more than 1 million square feet of County buildings. Its six divisions are Administration, Community Transportation, General Services, Operations, and Mechanical Services.

From Route 4 East or 4 West – Exit at Hackensack Avenue, Business District. Hackensack Avenue becomes River Street. From River Street make a right onto Kansas Street then right onto Hudson Street. Turn right at the corner of Bergen County Plaza.

From Route 17 North – Exit at Polifly Road. Four lights later, make a right onto Essex Street, cross over RR tracks. See Courthouse ahead. (Road curves and splits). Bear right onto Hudson Street and take your first left between the Justice Center and One Bergen County Plaza.

From Route 17 South – Exit at Essex Street (Maywood-Paterson). Make a left at the stop sign onto Essex Street. Stay on Essex over Route 17, past Hackensack University Medical Center over RR tracks. Proceed as above from Route 17 North.

From Route 80 West – Exit at #66 (Hudson Street, Hackensack, Little Ferry) Go to light. Make a left onto Hudson Street. As Hudson Street starts to curve, see Courthouse ahead. Make a right between Justice Center and One Bergen County Plaza.

From Route 80 East – Exit at #65 (Green Street, South Hackensack). At end of ramp, make right and proceed to light. Turn right onto Green Street and proceed to end. Turn right onto Essex Street. See Courthouse ahead. Bear right onto Hudson Street and make a left between the Justice Center and One Bergen County Plaza.
